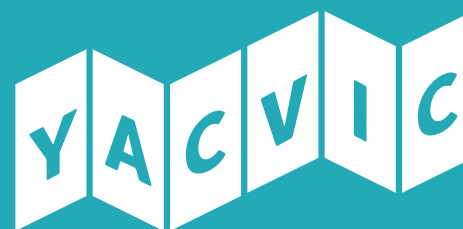

YACVic at a Glance

The Youth Affairs Council of Victoria (YACVic) is the peak body and leading policy advocate on young people's issues in Victoria. YACVic's vision is that young Victorians have their rights upheld and are valued as active participants in their communities.

YACVic is an independent, not-for-profit, member driven organisation that represents young people (aged 12-25 years) and the sector that works with them. We advocate on behalf of our members by making representations to government and in the media, convening meetings of our members and sharing information.

YACVic is governed by a volunteer Board, up to half of whom are young people, and is run by a core secretariat. Our work is primarily funded by the Victorian Government Office for Youth.

YACVic provides services, including YACVic Rural and the Youth Disability Advocacy Service (YDAS) and auspices and supports partner agencies, including the Koorie Youth Council (KYC) and the Victorian Student Representative Council (VicSRC).

Guiding Principles

YACVic's work is guided by the Code of Ethical Practice for the Victorian Youth Sector. This means that the recognition of young people's human rights underpins everything we do.

YACVic promotes active participation of young people in all aspects of decision making and community life.

YACVic pursues social justice by maintaining a focus on those in the community who face disadvantage or marginalisation.

YACVic works in collaboration with young people, our members, our core and partner agencies, and the wider Victorian youth sector.

Recognition of Indigenous Peoples

YACVic staff and volunteers recognise that we live on the traditional lands and waters of the Indigenous peoples of Australia. We recognise that culture and connection to land and community is a right for young people who are Indigenous and that they have a right to cultural safety. YACVic staff and volunteers will be respectful of Indigenous culture at all times, and recognise the importance of culture as it relates to the self-esteem and sense of identity of young people who are Indigenous.

Child Safe Standards

YACVic promotes the safety, wellbeing and inclusion of all children and young people, including those with a disability, those who are Aboriginal or those from refugee or migrant backgrounds.

Monitoring Our Success

YACVic's leadership team will report to the Board bi-monthly on our progress against objectives 1, 2 and 3. YACVic will report annually to our members on our progress against these objectives through our annual report.
